Human rights education at Holocaust memorial sites across the European Union: An overview of practices

Most European Union (EU) Member States have memorial sites and museums that both preserve the memory of the Holocaust and encourage visitors, in particular young people, to reflect on current human rights issues. In this handbook, the European Union Agency for Fundamental Rights (FRA) provides examples of the various ways in which memorial sites link the history of the Holocaust to human rights, ensuring that the past resonates in the present and its lessons are brought to bear on difficult contemporary issues against its backdrop.

The report offers a sampling of educational programmes at selected historical sites and museums that either address human rights directly or approach, in a more general way, the dignity of human life and the equality of all human beings.

More than 107 Asylum Seekers in Belgium Hotels

Belgium is rapidly processing the asylum cases for refugees still domiciled in hotels, one year after arriving in the country.

There are now 107 asylum seekers lodged in Belgian hotels, all of whom are unaccompanied minors, down from nearly a thousand earlier in the year. The objective of the Belgian Government is to have no asylum seekers in this form of accommodation at the year's end.

A more rapid processing of asylum applications will be established - applicants will receive a response within 15 days. Appeals will no longer suspended and the burden of proof will be reversed, the onus being on the plaintiff to prove that he needs the protection of Belgium, and not vice versa.
