Resolution on the promotion of volunteering

On 12th November 2010 the Parliamentary Assembly of the Council of Europe (PACE) has approved a Resolution on the promotion of volunteering.

The resolution is aimed at:

- supporting the 2011 European Year of Volunteering,
- promoting the access to voluntary service
- setting up a social protection system for volunteers
- promoting "food banks"
- encouraging the development of voluntary activities
- creating a legal framework for voluntary work
- recognising that volunteer work is one of the few areas where there exists a balanced participation of women and men and thus build bridges with the political sector.
