Promise to end violence against women is commitment which must be honoured

In the run-up to International Women's Day, the President of the Parliamentary Assembly of the Council of Europe (PACE), Jean-Claude Mignon, has issued the following declaration:

"8 March is an auspicious annual occasion for all those involved in promoting women's rights. This year the event will have the theme of 'A Promise is a Promise: Time to Act to End Violence against Women'.

The Council of Europe has a major instrument at its disposal, namely the Convention on preventing and combating violence against women and domestic violence, also known as the Istanbul Convention. This is the first binding text combining all the necessary ingredients: preventing violence, protecting victims, prosecuting those responsible and implementing integrated policies.

The promise to end violence against women is a commitment which must be honoured. The Istanbul Convention provides states with the means of doing so. On 8 March I shall be appealing to Council of Europe member and non-member states, if they have not yet done so, to sign and ratify the Istanbul Convention."

Training manual for capacity building and awareness-raising of civil society organisations dealing with anti-discrimination and equality

In the framework of the project "Awareness-raising in the areas of non-discrimination and equality targeted at civil society organisations", the Migration Policy Group designed and produced specific training material that aim at strengthening the capacity of NGOs to deal with non-discrimination and equality. All grounds protected by Directive 2000/43/EC and Directive 2000/78/EC were covered and gender-related aspects was mainstreamed into all activities.

The manual contains specific sections on each of these topics, forming the core of the training manual. Each file below also includes a document on national context material.
