Laws and policies on prostitution are indispensable anti-trafficking tools

Strasbourg, 08.04.2014 - With 84% of trafficking victims in Europe subjected to sexual exploitation, the **Parliamentary Assembly of the Council of Europe** has pinpointed legislation and policies on prostitution as indispensable anti-trafficking tools, given the obvious close link between trafficking in human beings and prostitution. The parliamentarians acknowledge that it is difficult, though, to propose a single model of prostitution regulations that would fit all member States. The resolution adopted today points out that, depending on the countries, prostitution legislation and policies range from legalisation to criminalisation, with a number of systems combining the two approaches to varying degrees. But, following the conclusions of the rapporteur, José Mendes Bota (Portugal, EPP/CD), the Assembly stated that criminalising the purchase of sexual services, based on the Swedish model, appears as the most effective tool for combating trafficking in human beings.



Discrimination is "alive and well"

On 10 April the French national statistics institute INSEE **published** a compilation of 11 different studies measuring the influence of gender, ethnic origin, sexual orientation and health status on inequalities in different areas of society. The interesting conclusions that can be drawn from this research include the existence of striking differences in treatment that can't be explained by other factors than discrimination, in areas such as access to social housing, employment and education. The general conclusion which is drawn is that the white, heterosexual male aged 30-50 remains privileged compared to all other groups of people in today's society.

These data corroborate previous findings of the European Network of Legal Experts in the non-discrimination field, such as for instance those of the recent thematic report **Discrimination in housing**, authored by Nicolas Bernard and Julie Ringelheim in 2013. It also demonstrates the importance of having relevant equality data to be able to prove the existence of discrimination, and to raise an effective fight against it. This is the main aim of the **Equality Data Initiative** of the Open Society Foundations, MPG and ENAR, which focuses on equality data collection in seven European countries, including France.

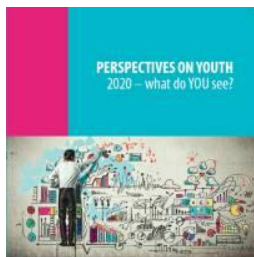
Participate online in the European Youth Event



The EYE 2014 will include a large variety of activities run under the motto "Ideas for a better Europe" in a political, social and cultural sense. Activities will focus on five main themes: youth unemployment, digital revolution, future of the European Union, sustainability and European Values.

During the EYE2014 event, the Council of Europe will present its campaign, which will kick off the debate on human rights on the internet. In the YO! Village outside the Parliament's buildings, the Council will showcase its Living Library. This involves 25 people who have been a victim of discrimination talking about their experiences and how it has affected their lives.

Discrimination based on race, ethnicity, religion or sexual orientation is nothing new on the web, it happens every day, and the consequences are serious. A Eurobarometer study shows that cyber bullying among children and teens can affect their school performance and often leads to depression or even suicidal tendencies among the victims. For instance, in Belgium more than a third of all teenagers claim to have been victims of cyber-bullying at least once.



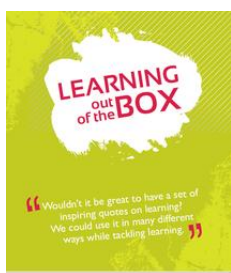
Perspectives on youth. Issue #1 now available!
