### Convention against sexual exploitation and sexual abuse of children enters into force


This new Council of Europe convention to combat sexual violence against children is the first international instrument to tackle all forms of sexual violence against children, including abuse perpetrated within the family environment. Apart from sexual abuse, child prostitution and pornography and coercing children into participating in pornographic performances, the convention also deals with grooming and sex tourism.

### 3rd Integration Handbook at the European Integration Forum

The third edition of the Handbook on Integration for Policy-makers and Practitioners, written by MPG's Jan Niessen and Thomas Huddleston, was distributed in all EU languages at the third European Integration Forum held on June 24-25 in Brussels.

The Handbooks on Integration act as a driver for exchange of information and best practice, and enable the development and promotion of policy initiatives. The three editions of the Handbooks are collaborative products of the European Commission, the National Contact Points on

Integration, and MPG as independent consultant, all of whom can be seen as "editors" of the Handbooks.

The third edition of the Handbook was published in April 2010. The second edition was published in May 2007 and the first edition was published in November 2004.

The "For Diversity. Against Discrimination" campaign works to raise awareness of discrimination on the grounds of racial and ethnic origin, religion or belief, age, sexual orientation and disability. For that purpose, the campaign supports events organised in the EU Member States on the topics of diversity and the fight against discrimination. In April, May and June, the campaign joined events in Austria and Estonia:

- On 24 April 2010, the third Diversity Ball was held in Vienna to inform and raise awareness of the topics of anti-discrimination and diversity among representatives of civil society, social partners as well as business and governments.

- On 22 May 2010 "Party on wheels" took place in Tallinn, Estonia, where people in wheel chairs gave an insight to visitors of their everyday life living with a disability.
