What are human rights?

They are rights which exist because you are human. Nobody has given them to you. Nobody can take them away. They are a part of being human.

Therefore all people have them, equally. They do not vary with your intelligence or race or politics or gender. Some may be restricted until you are a certain age. But they are held equally, universally and forever.

There are other limits on them – they are not unfettered or unrestricted. Every right involves a responsibility – to not act in a way which would infringe somebody else's rights.

Also, the state may impose some limits on their exercise – e.g. freedom of movement can be taken away for prisoners.

What is International Human Rights Day?

On 10 December 1948, the United Nations General Assembly adopted the Universal Declaration of Human Rights, which has become a universal standard for defending and promoting human rights.

Every year on 10 December, Human Rights Day marks the adoption of the Universal Declaration. On Human Rights Day it is celebrated around the globe that "All human beings are born with equal and inalienable rights and fundamental freedoms".

Why celebrate International Human Rights Day?

Setting aside a day to celebrate, educate and reflect on the principles that form the UDHR means celebrating the rights we exercise everyday, and acknowledging that enjoying those rights carries with it the responsibility of promoting these rights for all people.

Things that many of us take for granted – such as the right to an education, the right to receive medical care, and the freedom to practise our chosen religion – are not equally available to all people in the world.

Many individuals and communities will be commemorating and celebrating December 10, and pledging a commitment to maintain and improve people's human rights wherever possible.
