21st March European-wide Action Week Against Racism

March 21st was declared International Day for the Elimination of All Forms of Racial Discrimination by the General Assembly of the United Nations as a reaction to the murder of 69 anti-apartheid demonstrators in Sharpeville, South-Africa, in 1960.

During the annual European-wide Action Week, which centres around 21 March, thousands of people actively engage themselves for tolerance, equal rights and celebrate the diversity of Europe. This campaign aims to highlight the issues of racism from a non-gouvernmental perspective on all levels - local, national and European.

Global Action Week 2008: "Quality Education to End Exclusion"

Global Action Week is taking place from 21-27 April 2008 on the theme of "Quality Education to End Exclusion", a top EFA priority. UNESCO is organizing activities world-wide to highlight the issues of quality and inclusion according to the local context.

Quality and inclusion are key factors in attaining Education for All, UNESCO's top priority, and are at the heart of this year's Global Action Week. Numerous events in the Organization's field offices, a session of the "World's Biggest Lesson" (23 April) and a monthlong internet forum are among the events planned during the Week.

The objective of this call is to promote the debate on discrimination and diversity in the PROGRESS participating countries and to foster the dissemination of information on EU and national policy and legislation in the antidiscrimination field.

European Commission wishes to support activities which tackle at least one of the following 5 grounds of discrimination: race and ethnic origin, disability, age, religion or belief and sexual orientation.

Supported activities:

- 1. Training activities relating to the content and practical implementation of Directives 2000/43/EC and 2000/78/EC.
- 2. Organisation of events raising awareness about discrimination on the grounds of disability, age, racial and ethnic origin, religion or belief and sexual orientation and/or promoting the benefits of diversity.
- 3. Identification, analysis, promotion and dissemination of good practices in the antidiscrimination field.
- 4. Type of activities building on or continuing national initiatives undertaken as part of the 2007 European Year for Equal Opportunities for All
