Council of Europe's anti-racism body calls for timely action against political parties that promote racism

Strasbourg, 10 July 2014 - The European Commission against Racism and Intolerance (ECRI) today published its annual report, calling for timely action against extremist organisations that promote racism to avoid an escalation of violence and related criminal activities. ECRI noted a surge in support for aggressive nationalist and populist xenophobic parties and the persistence of fascist World War II nostalgia in several member states. The report, which examines the main trends in 2013, says that more needs to be done to communicate a positive image and the advantages of a diverse society and urged countries to adopt national action plans to fight racism and discrimination.

The MPs called the European Commission as well as the Member States to do more in order to tackle the problem of youth unemployment in the whole Europe. They urged for an 'European legal framework, introducing minimum standards for the implementation of the youth guarantees, including the quality of apprenticeships, decent wages for young people and access to employment services'. As far as the Youth Employment Initiative is concerned, the European Parliament blamed a lack of funding: a greater budget provided by the European Commission will be needed for the next seven years. 6 € billion are not sufficient, the At national level, additional measures need to be settled: measures to discourage young people from dropping out of school, promoting training and apprenticeships, and comprehensive strategies for those who are not in employment, education or training.The resolution also underlined importance for young people of acquiring skills that would make them more employable, such as knowledge of information technologies, leadership skills, critical thinking and languages.

A seminar on youth participation in the EECA region will be organised on 14-16 October in Chisinau, Republic of Moldova, with the main purpose to present and discuss the findings of the experts' reflection group on youth participation organised by the EU-CoE youth partnership in the first semester of 2014 and to examine their relevance for the EECA region.

The thematic scope of the seminar will encompass theoretical and political reflections on the motivation to promote participation, on new trends and all forms of youth participation, and on their recognition by the institutions and society at large. Moreover, practical examples of youth participation will be presented. The contexts of the EECA countries and especially the Republic of Moldova will be given particular importance.

The EU-CoE youth partnership is looking for participants for this event. The seminar is particularly addressed to representatives from Eastern Partnership countries as well as the Russian Federation and the Visegard 4 countries, not excluding participants from other member states of the Council of Europe and the European Union. Applications should be made online including information on the motivation and the experiences / knowledge in youth participation that the candidates might want to share with all participants.

A public consultation on the Europe 2020 strategy is open until October 2014

The public consultation on the European 2020 strategy is organized by the European Commission, Unit SG D1 "Europe 2020, European Semester, Economic Governance" and it will be open until 31 October 2014.

You may reply in any of the 24 official EU languages. The reply may be published in the language of submission.

Contributions will be published on the public consultation website. Submissions that are clearly marked as "anonymous" will be treated as such and published without personal information. Submissions indicated as "not for publication" will be treated as such and will not be published.

After closure of the public consultation, the Commission will analyse and process the replies received. Based on the outcome of the public consultation, the Commission will make proposals for the further development of the strategy in early 2015.
