Call for the production of two animated cartoon movies on youth work today

The EU-Council of Europe youth-partnership - is looking for an expert/service provider, e.g. a media agency which is specialized in producing and distributing web-based and graphically animated media content. We expect a close cooperation and contact with the organisers of the 2nd European Youth Work Convention and the team of the EU-Council of Europe youth partnership when designing and developing the concept of the two films. This process-oriented co-operation should guarantee an optimized output. In particular the expert/service provider will be charged with:

- designing and developing the two films on youth work as described in the call, starting with a conceptual development in terms of graphical elements (videos, infographics, cartoons...);
- coordinating and acting as a point of contact for the EU-CoE youth partnership and the Belgian organisers during the development and realisation phase;
- presenting the films on the occasion of the 2nd EYW Convention.
